Wed Feb 3, 2010	<p>Preliminary Placements posted Note: After reviewing preliminary team placements, coaches may submit a written appeal to the Games Committee requesting a review of their team's placement.</p> <p>Written Appeals may be submitted by email or FAX ONLY Email: cdyslGAMES@cdysl.org or FAX (518) 435-2328 and must be received no later than Sunday Feb 8 at 5pm (Sorry our time table is too short to handle "regular" mail.)</p>
Sun Feb 7, 2010	Deadline for Appeals to Team Placement assignments (except for U19 divisions)
Mon Feb 8, 2010	<p>Tentative date for Appeals hearing Location TBA All placement appeals will be reviewed by the Games Committee at this meeting. While attendance by coaches who submit appeals is not necessary, additional comments are welcome, and usually helpful. Any coach may attend the hearings to observe the process and voice their opinions regarding how potential changes may impact their team's final placement.</p>
Wed Feb 10, 2010	<p>Final Placements posted - No additional appeals Final team placements reflect changes approved by the Games Committee during the Appeals process as well as any realignment need if teams withdrew after preliminary placements were posted.</p>
TBA	<p>Special Meeting for U19 Coaches to determine team placement and scheduling guidelines will be set up after final placement of other divisions Note: Due to the wide variety of situations that arise when setting up teams in these divisions, past history has shown us that getting the coaches involved together separately leads to better competition among the divisions and few scheduling problems.</p>
Tue Feb 23, 2010	Last date to withdraw teams without penalty
Mon March 15, 2010	<p>Initial Team Registration Deadline: This deadline allows CDYSL sufficient time to process your paperwork so coaches will have signed rosters and passes to start the sanctioned play. Do not hold up registration of an entire team for one or two players they can always be added later</p>
Mar 22-25, 2010 Mon Mar 22 Tues Mar 23 Wed Mar 24 Thur Mar 25	<p>Mandatory Coaches Meetings, Preliminary Master Schedules distributed</p> <p>Coaches Mtg. - U8-10 Only Coaches Mtg. - U12-14 Only Coaches Mtg. - U16-19 Only Coaches Mtg. – All ages (missed assigned Age Groups)</p> <p>Note: All teams must be represented either by a coach or team manager. Teams failing to attend will forfeit the ability to reschedule games for any reason except those that are weather related.</p> <p>Coaches will have until April 1st to review preliminary schedules, identity conflicts, contact opposing coaches to reschedule games at NO charge (established guidelines for rescheduling must still be followed)</p>
Thurs Apr 1, 2010	Deadline for Rescheduling requests at no charge. Requests dated after April 1 st will be assessed rescheduling fees
Fri April 9, 2010	FINAL Master Schedule posted
