November 17, 2017	Team Commitment Opens	Online team commitment form opens. One form must be completed for each team participating in league play.
January 12, 2018	Commitment Due	A commitment packet consists of: <ul style="list-style-type: none"> • Team Commitment Summary Sheet *to be submitted in hard copy • One NEW Field Commitment Form for each NEW field you will be using this spring (previously submitted fields will need to be updated or approved online by the field coordinator or club president) • One Team Placement Form for each team that will be playing this spring • Payment for all teams (\$110 per team) *to accompany <i>Commitment Summary Sheet</i>
January 23, 2018	Preliminary Placements Posted	Preliminary divisional placements will be posted.
January 29, 2018	Placement Appeals Due	Any team wishing to appeal their placement must appeal in writing by 1/29/18. Any and all appeals regarding divisional placements must be submitted to the office in writing. Forward appeals to Karolyn Thompson at karolyn.thompson@cdysl.org.
February 1, 2018	Placement Appeals Meeting	Meeting location and time to be announced
February 7, 2018	Final Placement Posted	Final team placements posted
February 28, 2018	Last Day to Withdraw	Any teams withdrawing after 2/28/17 will forfeit the commitment fee and incur a fine.
February 28, 2018	Player Registrations Due	All player registrations must be in the CDYSL office by 2/28/18. This means the complete registration packet for a team must be submitted. A complete registration packet includes: <ul style="list-style-type: none"> • A not approved roster printed from the Sports Illustrated Play system • Risk management clearance for all adults listed on roster (coaches/managers) • All coaches on roster must be certified • Player passes for all players and coaches listed on the roster • Registration worksheet • Payment for all player registration Any teams that fails to have the complete registration packet for their teams in the CDYSL office by this date will be fined \$50/team per week. This fine will increase by \$50 each week that registration remains outstanding. (<i>week 1-\$50, week 2-\$100, week 3-\$150, week 4-\$200</i>) This fine will be assessed for a maximum of 4 weeks. Any team whose registration is not in the office as of April 1, 2018 will be removed from the spring league and will be assessed the \$500 late team withdrawal fee as well as forfeit their \$110 team commitment fee. Any team that is withdrawn WILL NOT be allowed to re-enter the league.
March 10, 2018	CDYSL Coaches' Workshop	Coaches' Workshop to be held at Sand Creek Middle School
March 18, 2018	Opening of FREE rescheduling period	Any and all changes can be made to your schedule free of charge with the approval of the opposing coach. All rescheduling MUST go through the online rescheduling system. <i>*Teams/clubs are responsible for determining field availability.</i>
April 1, 2018	Late Withdrawal Date	Any team being withdrawn on or after April 1 will forfeit their team commitment fee and will be assessed a \$500 late withdrawal fee.
April 2, 2018	Last Day for FREE Reschedule	Last day to reschedule with no fee.
April 3, 2018	Regular Rescheduling Period Begins	Regular rescheduling policy in effect. Any and all games can be rescheduled for any reason with the consent of the opposing coach. Rescheduling fees may apply. No games can be rescheduled past July 8, 2018.
April 22, 2018	League Play Begins	CDYSL spring league play begins <ul style="list-style-type: none"> • No games will be scheduled on Mother's Day weekend, Memorial Day Weekend or Father's Day weekend.
June 30, 2018	League Play Ends	CDYSL spring league play ends June 30, 2018, however rescheduled games can be played until July 8, 2018.
