December 15, 2021	Team Commitment Opens	Online team commitment form opens. One form must be completed for each team participating in league play.
January 24, 2022	Team Commitment Due	A commitment packet consists of: <ul style="list-style-type: none"> • Team Commitment Summary Sheet *to be submitted in hard copy • Venue and Field Commitment Information for each field you will be using this spring will need to be updated or added online by the field coordinator or club president) • Payment for all teams (\$125 per team) *to accompany Commitment Summary Sheet
January 25, 2022	Late fee assessed for any teams added	Any clubs requesting to submit a team to play in the Spring League after 1/24/22 will be assessed a Team Commitment Fee of \$250 for additional office work required. No teams will be accepted after 2/4/22.
February 14, 2022	Preliminary Placements Posted	Preliminary divisional placements will be posted.
February 22, 2022	Placement Appeals Due	Any team wishing to appeal their placement must appeal in writing by 2/22/22 . Any and all appeals regarding divisional placements must be submitted to the office in writing . Forward appeals to Jan Brown at jan.brown@cdysl.org .
Feb 23-25, 2022	Placement Appeals Mtg, if necessary	Meeting location and time to be announced
February 28, 2022	CDYSL Player Registrations Due	All player registrations must be in the CDYSL office by 2/28/22. This means the complete registration packet for a team must be submitted. A complete registration packet includes: <ul style="list-style-type: none"> • Risk management clearance for all adults listed on roster (coaches/managers) • All coaches on roster must have a coaching license • Registration worksheet • Payment for all player and coach registrations • Add/Drop/Transfer Form and previously approved roster, if necessary <p>Any teams that fails to have the complete registration packet for their teams in the CDYSL office by this date will be fined \$50/team per week. This fine will increase by \$50 each week that registration remains outstanding. (week 1-\$50, week 2-\$100, week 3-\$150, week 4-\$200) This fine will be assessed for a maximum of 4 weeks. Any team whose registration is not in the office, or does not have enough players to field a team (with rostered and guest players) as of April 1, 2022 will be removed from the spring league and will be assessed the \$500 late team withdrawal fee as well as forfeit their \$125 team commitment fee. Any team that is withdrawn WILL NOT be allowed to re-enter the league.</p>
March 4, 2022	Final Placement Posted	Final team placements posted.
March 4, 2022	Last Day to Withdraw	Any teams withdrawing after 3/4/22 and 4/1/22 will forfeit the commitment fee and incur a fine of \$250
March 12, 2022 Tentative date	CDYSL Coaches' Workshop	Coaches' Workshop TBD
March 14, 2022	Schedules Posted/ Opening of FREE rescheduling period	Any and all changes can be made to your schedule free of charge with the approval of the opposing coach. All rescheduling MUST go through the online rescheduling system. *Teams/clubs are responsible for determining field availability.
April 1, 2022	Late Withdrawal Date	Any team being withdrawn on or after April 1 will forfeit their team commitment fee and will be assessed a \$500 late withdrawal fee.
April 1, 2022	Last Day for FREE Reschedule	Last day to reschedule with no fee.
April 3, 2022	Regular Rescheduling Period Begins	Regular rescheduling policy in effect. Any and all games can be rescheduled for any reason with the <u>consent</u> of the opposing coach. Rescheduling fees may apply. No games can be rescheduled past July 1, 2022.
April 24, 2022	League Play Begins	CDYSL spring league play begins No games will be scheduled on Mother's Day weekend, Memorial Day Weekend or Father's Day weekend.
July 1, 2022	League Play Ends	<ul style="list-style-type: none"> • CDYSL spring league play ends July 1, 2022.
